

TENDER NOTICE

Sealed tenders are invited from bonafide contractors / suppliers for the supply of dietary (Grocery / Vegetables / Miscellaneous) articles under Group – A and Group - B for the period from 01/07/2011 to 30/04/2012 for Bankura State Welfare Home, Gobinda Nagar. The list of articles be obtained from the office of the State Welfare Home, Bankura from 11 AM to 4 PM in any working days from 02/06/2011 to 22/06/2011.

The terms and conditions are as follows:

1. Tender will be received by the Superintendent, Bankura State Welfare Home, from 02/06/2011 to 23/06/2011 in any working days & the same be received upto dated 23/06/2011 at **2.00 PM** i.e the closing date of this tender. The Treasury challan showing deposit of **an earnest money of Rs. 500/- (Rupees Five Hundred)** only for each group under the head "**8443-Civil deposit**" which will be refundable to the successful tenderer, is to be submitted with the tender application. The successful tenderer will get the money back after the term of contract be over on the basis of successful completion of the supply. Earnest money will be forfeited if the contract fails to execute the supply as per indent issued to the contractor. The earnest money in case of unsuccessful tenderers is to be refunded in due course on the basis of the respective prayer.
2. The tender must be submitted with the Income Tax, Sales Tax clearance certificate along with the three years credential certificate as working experiences on such type of supply of dietary articles.
3. Tender must be dispatched in sealed cover and addressed to the District Mass Education Extension Officer, Bankura and marked on the envelop "**Tender for the dietary and miscellaneous articles for the State Welfare Home, Bankura**".
4. The rate must be quoted in figure and the items as well as serial be maintained as per list of articles obtained for this tender. The declaration for supply articles must have to be fresh and good quality and the rates must be **metric** weight and measures.
5. The security deposit and the earnest money are liable to forfeit in case of unsatisfactory supply or failure to supply according to the indents placed by the Superintendent, Bankura State Welfare Home.
6. The successful tenderer will have to deposit 5% of the total value of the articles to be supplied during the whole period as a security deposit within a fortnight from the date of acceptance of the tender as a condition.
7. The successful tenderer/ tenderers will have to execute an **agreement on a non-judicial stamped paper worth Rs. 10/-** in the prescribed form before the supply order is issued.
8. The supply of the articles should be made at the site of the Bankura State Welfare Home and the cost of conveyance should be borne by the contractor / Supplier.
9. The articles which are not included in the tender should also be supplied according to indents placed by the Superintendent, Bankura State Welfare Home and cost of such articles will be paid to the contractor at market rates from time to time.
10. The undersigned does not bind himself to accept the lowest tender on the contrary reserves the right of reducing the items, rates and curtailing the period of supply without assigning any reason what so ever. The undersigned also reserves the right to cancel any tender or tenders without assigning any reason what so ever.
11. Tender will be opened on 23/06/2011 at 3.00 PM. by the District Mass Education Extension Officer, Bankura, at Bankura State Welfare Home.
